

## NATO Standardization Process



## Phases 4/5: Ratification/ Approval & Promulgation

Approval of Allies to promulgate NATO standardization documents is achieved through either the ratification process or the approval process.

Phases 4&5

Ratification / Approval & Promulgation

- STANAG Ratification
- STANREC Approval (Silence Procedure)



Promulgation

#### **Standard Related Documents**

- as part of a ratification or approval process package (SRDs shall be included as related documents within the covering document), or
- by separate approval (silence procedure), if the SRD is planned to be linked to an already promulgated Allied standard.

«In NATO standardization, the process by which a NATO member state determines its position regarding the implementation of a NATO standardization agreement»



### Ratification Process


### Ratification

- process in which Allies analyse the standards covered by a STANAG in order to identify how to implement them,
- completion of process results in formal ratification response by which Allies confirm their commitment to a STANAG,
- Allies should complete staffing for ratification and reply within the timescale set by TA/DTA.



# Ratification Analysis - Assessment



## Ratification Responses – Amplifying Remarks

### 1. COMMENTS:

«A comment is an amplifying remark, other than a reservation, expressed by a Nation as part of its ratification response»

«Comments **should not express a limitation** or restriction on the Nation's **implementation**»

#### 2. RESERVATIONS:

«A reservation is a formal statement by which a Member Nation describes the part of the document or documents covered by a STANAG that it will not implement or will not implement in full»

## Ratification Process Responsibilities

TA/DTA STAFF: ■ check format and terminology and submit

■ FD+RD

TA/DTA approve FD+RD, promulgation criteria and

timeline for ratification

TA/DTA STAFF: submit FD+RD, prom. criteria and timeline for

ratification to NSO

**NSO:** distribute FD+RD and request for ratification

NSO: include FD+RD in NSDD

**ALLIES:** respond to request for ratification

NSO, TA/DTA STAFF: assess ratification responses

PROMULGATION CRITERIA MET

**NSO:** submit promulgation request

**ALLIES:** approve promulgation

**NSO: Promulgate**, distribute and include in the **NSDD** 

## Ratification Challenges

- Missing ratification responses
  - long ratification process with extensions
  - delayed promulgation
  - unknown national positions
- High number of responses "ratifying, future implementation"
  - unclear national position

## Ratification Responses & Standards Custodians

#### After Ratification:

- Review the National Reservations and Comments, subject for consideration in the next revision
- Promote and Monitor the integration of the standard(s) in Exercises and Evaluations
- Collect LL from the Implementation of the Standard(s)
- Monitor SDOs activities in relevant standards

# Ratification Responses Takeaways

- Ratification is not Implementation by default
- Implementation feedback/report is the evidence for interoperability
- Responses with Future Implementation and Future Implementation with no time lines and reservations do not help national defence standardization program offices and NATO to evaluate interoperability levels
- Self criticism, evaluation and realistic responses are better than the political correct responses - in bottom line they are saving lives

## STANREC Approval Process Responsibilities

TA/DTA STAFF:

check format and terminology and submit

FD+AD

TA/DTA

approve FD+AD and timeline for approval

TA/DTA STAFF:

submit FD+AD and timeline for approval to NSO

NSO:

distribute FD+AD and request for approval

NSO:

include FD+AD in NSDD

SILENCE PASSED

NSO:

promulgate, distribute and include in the NSDD

Administrative Publications which are not covered by a STANAG or a STANREC are also approved using the silence procedure.

## Promulgation of NATO Standardization Documents

- □ Promulgation is a formal act by which the Director of the NATO Standardization Office publishes a NATO standardization document, following a recommendation by the tasking authority or delegated tasking authority.
- ☐ The Letter of Promulgation defines the following:
  - ☐ The document comes into force on the date of publication, unless a NATO Effective Date (NED) is specified
  - ☐ Allies which have not responded to a ratification request within time allocated by the TA/DTA, shall respond at any time after promulgation.
  - ☐ Allies may update their responses at any time.
- ☐ The NSO shall distribute the covering document to all relevant stakeholders and update the NSDD accordingly.

NATO Effective Date (NED) (and time if appropriate), is usually determined by operational requirements.

It is addressed in the Covering Document of an Allied Standard and is used when it is imperative for all participants to implement a new or revised Allied standard simultaneously.



Forces in Afghanistan cannot communicate effectively and share information. These gaps increase <u>risk to life</u>, resources and efficiency.




If, for the specification of the capability of a defence product or a service, standards or standard-like documents of different domains or origin are available and deemed suitable by the Purchasing Authority, they shall be selected and used in the following order of preference:

- Standards and other standard-like documents, which are referenced in laws, ordinances and statutory provisions;
- International Military Alliances Standards (e.g. NATO Allied Publications and associated Standardization Agreements (STANAG));
  - NOTE For NATO nations this applies if the standards are ratified (without reservations) with the intention of implementation for e.g. achieving the required interoperability between forces.
- c) National civil standards, transposing European standards (e.g. BS EN, NF EN, DIN EN,...);



- Adoption of the best practice model in standardization management governance
- Harmonization of NATO and National defence planning priorities
- Synchronization between NATO and National capabilities development process
- Collaboration with National SDO
- National Standardization Management tools in place
  - Standards Implementation Tracking Mechanisms /Tools in place
- Conformity Assessment Mechanisms Tools in place
  - Mutually recognized certification of products within Defence and Security Sectors
- National Education and Training Programs
- Communication and Awareness Plans
