Working Group A

1. Analyze the 'active standards' portfolio of the Subgroup B (SG/B) under the CNAD Ammunition Safety Group (CASG) - **CNAD DTA**:
 - identify activities required to be taken by the WG and develop tasks the CASG should give to this WG.
2. Identify and present challenges to NATO standardization from the NATO (NSO) perspective.
3. You are part of the writing team for the revision of **STANAG 4669** (Edition 2, see student folder). The DTA agreed that the content of the standard should remain unchanged. However, iaw AAP-03 the standardization agreement (STANAG) has to be separated from the standard.
Analyze the current implementation guidance, identify national actions required and draft the implementation paragraph for the new cover STANAG, providing sufficient and detailed guidance to assist nations and NATO bodies with implementation of the covered standard.

Working Group B

1. Analyze the 'active standards' portfolio of the Joint Capability Group on Intelligence, Surveillance and Reconnaissance (JCGISR) under the NATO Air Force Armaments Group (NAFAG) - **CNAD DTA**:
 - identify activities required to be taken by the WG and develop tasks the NAFAG should give to this WG.
2. Identify and present challenges to contribute to NATO standardization from the perspective of a national standardization manager.
3. You are custodian of ATrainP-1, covered by **STANAG 6023**. The DTA responsible for the standard asked you to revise the implementation paragraph and to provide more precise guidance to Allies in a new implementation paragraph. Analyze the current implementation guidance, identify national actions required and draft the implementation paragraph for the new cover STANAG, providing sufficient and detailed guidance to assist nations and NATO bodies with implementation of the covered standard.

Working Group C

1. Analyze the 'active standards' portfolio of the NATO Fuels & Lubricants Working Group (NFLWG) under Operational Energy Committee (OEC) – **LC DTA**:
 - identify activities required to be taken by the NFLWG and develop tasks the OEC should give to the NFLWG.
2. Identify and present pros/advantages for the adoption of civil standards by NATO.
3. You are part of the writing team for the revision of **STANAG 2036** (Edition 6, see student folder). The DTA agreed that the content of the standard should remain unchanged. However, iaw AAP-03 the standardization agreement (STANAG) has to be separated from the standard.
Analyze the current implementation guidance, identify national actions required and draft the implementation paragraph for the new cover STANAG, providing sufficient and detailed guidance to assist nations and NATO bodies with implementation of the covered standard.

Working Group D

1. Analyze the 'active standards' portfolio of the Military Engineering Working Group (MILENG WG) under the Military Committee Land Standardization Board (MCLSB) – **MC DTA**:
 - identify activities required to be taken by the MILENG WG and develop tasks the MCLSB should give to the PC.
2. Identify and present cons/risks for the adoption of civil standards by NATO.
3. You are part of the writing team for the revision of **STANAG 1169** (see student folder). You agreed that the content of the standard should remain unchanged. However, iaw AAP-03 the standardization agreement (STANAG) has to be separated from the standard.
Analyze the current implementation guidance, identify national actions required and draft the implementation paragraph for the new cover STANAG, providing sufficient and detailed guidance to assist nations and NATO bodies with implementation of the covered standard.
